

Excellence in RISA Awards Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. The Excellence in RISA Awards (the "<u>Contest</u>") and these Official Rules are governed, construed and interpreted under the laws of the United States. Valid only to legal residents of the United States who are eighteen (18) years of age and older at time of entry. All federal, state, local laws and regulations apply. Void where prohibited, taxed, licensed or restricted by law.

CONTEST PERIOD. This Contest begins April 28, 2025 and ends on June 30, 2025. ("Contest Period").

CONTEST SPONSOR. This Contest is sponsored and administered by RISA Tech, Inc., 27442 Portola Parkway, Suite 200, Foothill Ranch, California 92601 (the "<u>Sponsor</u>"). Participants agree to be bound by these Official Rules and the final decision of Sponsor.

ENTER ON-LINE BY: Participants will complete the online submission form found by visiting go.risa.com/risa-awards. Projects submitted must meet the following requirements:

- Projects must be fully constructed by June 30, 2025
- Projects must be "new construction" or existing structures that include significant changes, updates or reworks of the structure.
- Projects may be submitted by any member of the design and/or construction team.
- A company or person may submit multiple projects, given that they meet the above criteria.

Completed submissions include the following required information (collectively the "<u>Submission</u> <u>Materials</u>"):

- User Information
- Company Information
- Project Information (name, location, software used, project description)
- Model files (RISA or ADAPT)
- 6-8 high resolution image files (minimum 300 dpi)

DRAWING. The Prizewinner(s) will be selected by a panel of judges from all completed and posted entries based on the following criteria:

- Ability to utilize the structure to solve unique problems (30%)
- Creativity of structural design including unique use of materials and exposed structure (30%)
- Application and use of RISA products in structural design (30%)
- Visual presentation of project including images, model files, etc (10%)

The Prizewinner will be determined on or about October 1, 2025. All entries submitted will be used for the purpose of selecting the prizewinner as described in these Official Rules. If a prospective prizewinner is found ineligible or fails to comply with these Official Rules, his/her claim to a prize is forfeited and an alternate entry will be randomly selected.

PRIZE. The Prizewinners (3 total) will receive a commemorative plaque along with their project being featured prominently on the RISA website and within social media and other marketing communication. RISA will also make a \$500 donation to the charity of the Prizewinners choice. MSRP \$600.

The Prizewinner will be notified by Sponsor via email at the address provided with the submission. The Prizewinner will have five (5) business days to claim their prize. Prizewinners must sign and return an affidavit of eligibility and liability/publicity release within ten (10) business days of notification.
