# RISA Educational Licensing Program Description and Additional Terms

As of 30 April 2025

CERTAIN RISA SOFTWARE AND SAAS SERVICES ARE AVAILABLE TO QUALIFIED EDUATIONAL INSTITUTIONS AND THEIR STUDENTS, FACULTY AND OTHER EDUCATION USERS (AS DEFINED BELOW) FOR THE PRIMARY PURPOSE OF EDUCATION WITHIN AN ACADEMIC SETTING.

Educational Licenses are only to be used by eligible Education Users and/or Qualified Educational Institutions (as defined below). You may be required to show proof of eligibility if requested by RISA to access or continue to access Educational Licenses.

Education Users may only use an Educational License for purposes related to learning, teaching, or research and development as part of the instructional functions performed by a Qualified Educational Institution. Education Users may not access or use the Education Offering for commercial or professional purposes, training classes (including but not limited to classes open to the public), facilities management, or other for-profit purposes.

Educational Licenses issued to a Qualified Educational Institution (as further described in the "Use of Software I Qualified Educational Institutions" section below) may not be used by the facilities department of a Qualified Educational Institution. Only current Students and Faculty of such Qualified Educational Institution may access and/or use licensed software associated with the Educational License assigned to a Qualified Educational Institution, and Students and Faculty may be required to use their own individual RISA ID to access licenses.

Educational Licenses issued to an Education User under an Educational Student User License (as further described in the "Use of Software I Educational Student User License" section below) may only be used by the Education User to whom they are assigned and may not be utilized by any other Students and Faculty of the Qualified Educational Institution associated with such Education User (if any).

You are an **Education User** if you are any of the following:

- 1. An individual person who is an employee or independent contractor working for a Qualified Educational Institution ("Faculty")
- 2. An individual person enrolled as a student at a Qualified Educational Institution ("Student")
- 3. A Student or other individual who is registered and accepted or otherwise approved by a design competition organizer as a RISA-approved design competition participant (and, upon request by RISA, able to provide proof of such status) or an individual who provides guidance, advice, coaching, or instruction to competitors engaged in competing in a RISA-approved design competition (and, upon request by RISA, able to provide proof of such status) ("Design Competition User")
- 4. An individual user otherwise authorized in writing by RISA to access and use an Educational Licensing (an "Other Authorized Education User")

Examples of **Qualified Educational Institutions** include, without limitation, public or private:

- 1. Middle Schools and High Schools
- 2. Junior Colleges
- 3. Colleges, universities and technical schools, and
- 4. Home-school programs which belong to a nationally recognized home-schooling body or are expressly recognized by a local school governing body as an acceptable alternative to an accredited educational institution.

The term "Qualified Educational Institution" does not include non-accredited educational institutions; training centers; churches and other places of worship; hospitals, healthcare systems and research laboratories; libraries; and museums.

## Use of Software | Qualified Educational Institutions

Your authorization to use any Educational Licensing begins after your request through the **RISA Educational Grant Program** and when RISA establishes licensing access through the creation of an account associated with your Qualified Educational Institution within the RISA Customer Portal (<a href="https://portal.risa.com/">https://portal.risa.com/</a>). All Educational Licenses are valid until **July 15**th at which point they can be renewed for the next annual period.

All software will be distributed electronically and licensing provided with utilize RISA cloud-based network licensing. To learn more about RISA cloud licensing, visit <a href="https://risa.com/licensing-support">https://risa.com/licensing-support</a>.

The RISA Educational Grant Program includes 20 concurrent use licenses for the following products, with additional seats and products available upon request (but may require a fee):

- RISA-3D
- RISAFloor
- RISAFoundation
- RISAConnection
- ADAPT-Builder

A license administrator must be assigned to the account with the responsibility of all license management and distribution within the course/department of the Qualified Educational Institution

Licenses may be installed on computers controlled directly by you or by your educational institution (ie. for use in computer labs). Licensed users can only use a single license of a given product at a time.

Technical support will be provided to administrators and instructors only.

Changes to account administrators must be submitted in writing to RISA by emailing info@risa.com.

## Use of Software | Educational Student User Licenses

If Your Educational License is described as "Education Student User," then your access is available through a "pool" of licenses managed by RISA. Access to licensing must be requested (by product) by individual students or faculty each semester as access to the licensing will be reset at the end of a given semester. These licenses are available solely for individual use and your RISA ID cannot be shared with or accessed by any other person. You must login to the RISA Customer Portal (<a href="https://portal.risa.com/">https://portal.risa.com/</a>) using your RISA ID to download and install the requested software.

#### **License Termination**

RISA reserves the right to cancel/void access to any and all Educational Licenses if the software is being used for commercial purposes and/or if the license usage violates any of the terms stated above or the RISA End User License Agreement (<a href="https://risa.com/eula">https://risa.com/eula</a>) ("EULA"), the terms of which are incorporated herein by reference. In the event of a conflict between this document and the EULA, the terms of the EULA will control.
